### What is the Peace River Agreement?

The Peace River Agreement (PRA) is a significant source of funding for eight local governments in Northeast BC.

Signed in 2015, this agreement with the Province of BC recognizes that the local governments provide essential services and infrastructure to industries and their workers, but are unable to tax industrial operations outside of their municipal boundaries.

Annual funding from the Peace River Agreement helps the City of Fort St. John to provide and improve community services, such as recreation and cultural facilities, roads and sidewalks, and parks and playgrounds.



The Peace River Agreement evolved from its predecessor, the Fair Share agreement, which was originally established in 1994, and then renegotiated in 1998 and 2005.

### How is it used?

Without the Peace River Agreement there would be significant local property tax increases.

In 2022, Fort St. John received \$25.9 million in Peace River Agreement funding.

These funds, in addition to \$40 million of Peace River Agreement reserve funds, represent 89 percent of the City's capital projects budget. Capital projects are funded primarily by the Peace River Agreement, not by local property taxes.

In early years, the majority of funding was invested into road construction and paving. In more recent years, funding has been invested into developing and upgrading municipal facilities, parks and infrastructure, which make Fort St. John a great place to work and live.
