SUMMARY


In 2017, the City of Fort St. John, in partnership with the Peace River Regional District and the District of Taylor, created the first Parks and Recreation Plan for our community. This plan looked ahead 15 to 20 years and aimed to help the City make choices about things like parks, sports facilities, programs, and investments.

Then, in 2022, the City decided it was time to update this plan. Several ideas from the plan had been put into action, new maps and information were available, and there was a need to align it with other projects like the North Peace Leisure Facility Replacement Project. It was also wanted to share what they had achieved with the community and ask the public for their thoughts on what should come next.

This 2023 updated plan is based on feedback from more than 700 people and provides a fresh way to make decisions about parks and recreation for the next 10 years. This updated plan will ensure Fort St. John continues to be a great place for nature, business, and families.

VISION

Fort St. John will be a community where nature lives, recreation opportunities abound, and families are active and flourish.




COMPLETED RECOMMENDATIONS

Since the Parks and Recreation Plan was prepared in 2017, the City has completed many of the recommendations for improvements to our parks, trails, recreation facilities and events. Such as:

- Centennial Park upgrades, including new playground equipment, outdoor stage, and public washrooms
- Festival Plaza and public washrooms
- Kin Park redesign, including new play equipment, outdoor ice rinks, pavillion, pickleball courts and trails
- Toboggan Hill disc golf course
- Rotary Spray Park upgrades
- Bert Bowes Middle School asphalt running track and infield upgrades
- Urban Forest Strategy
- New multi-use paths with lighting
- Toboggan Hill Off-leash Dog Park
- Carrier Park improvements
- Tot Lot Park play equipment upgrades
- Pickel Park play equipment upgrades
- Mathews Park Skate Loop and lighting upgrades
- Upgrades to the Surerus Park soccer pitches
- Mathews Park equipment upgrades and washrooms
- Triangle Park improvements
- Over 500 new trees planted in various parks
- Exterior, lighting, and mechanical system improvements to the North Peace Arena
- Kids Arena Fieldhouse upgrades
- New electric ice resurfacer for the Pomeroy Sport Centre

- Mechanical system and ice plant improvements at the Pomeroy Sport Centre
- Indoor play structure at the Pomeroy Sport Centre
- Planning for the replacement of the North Peace Leisure Pool in partnership with the Peace River Regional District and the District of Taylor
- Operationalized many of the recommendations from 2017 Parks and Recreation Plan, such as:
 - Continue to maintain all-season trails
 - Maintain and flood outdoor ice rinks and provide increased outdoor ice opportunities
 - Increasing operations resources and budgets as population grows and new elements are added to existing parks
 - Added security to monitor parks and recreational facilities
 - Implemented Crime Prevention Through Environment Design (CPTED) principles
 - Increased promotions of opportunities and financial assistance programs



COMMUNITY INPUT

The Parks and Recreation Plan update process provided an opportunity to share successes and accomplishments with the community and to gather input on the remaining 2017 priorities and new recommendations.

This Parks and Recreation Plan is based on the values and interests of the public, partners, staff, and elected officials of the City and surrounding communities.

During the initial plan development, extensive engagement with a wide range of residents was conducted, including telephone and web surveys, workshops, and numerous pop-up booths.

The 2023 plan update also included multiple engagement opportunities seeking input on the remaining 2017 priorities and new recommendations.

ENGAGEMENT METHODS













GOALS AND OBJECTIVES

The goals and objectives provide guidance on directions that will be taken to meet community needs. These are based on the 2017 objectives, with minor revisions to reflect the community input received in 2022. The goals are organized within themes, and objectives follow each goal.



CONNECTIVITY & Accessibility

Provide a multi-use, connected trail system that links parks and other key destinations

- Expand the trail system to better connect destinations such as downtown and city parks, and to integrate city trails with routes that extend to natural areas beyond the city
- Improve accessibility to and within parks and recreation facilities through the application of universal design principles
- Design well-connected, multi-purpose trails for walking, running, hiking, cycling, crosscountry skiing, snowshoeing, and off-leash dog walking
- Enhance year-round use of trails by snowclearing and grooming for cross-country skiing
- Expand amenities such as places to sit, rest and picnic along trails
- Connect city neighbourhoods to Fish Creek Community Forest, Charlie Lake, airport and Taylor
- Improve signage and maps for parks and trails



SOCIAL CONNECTIONS & COMMUNITY ENGAGEMENT

Provide opportunities for social gatherings and connections within parks and recreation facilities

- Distribute a range of parkland types across all neighbourhoods in the city
- Provide spaces within parks and recreation facilities for large and small gatherings
- Encourage and support more festivals and events
- Provide outdoor spaces for various types of events
- Include community engagement in the planning, design, and programming of activities
- Encourage and support volunteerism and community groups through marketing, assistance, and incentives



- Consider adaptive re-use of existing facilities to address deficiencies and to meet changing needs
- Expand multi-use opportunities in buildings, parks, trails, and public spaces
- Expand programs and services to include people with varying schedules, considering daily, weekly and seasonal use patterns



ENVIRONMENT & AESTHETICS

Protect and enhance the natural environment and aesthetics of the City's parks

- Protect existing natural areas at the edge of the city and within parks
- Naturalize areas within parks and prioritize the use of indigenous plants and trees
- Increase the number of trees in parks and along streets in the city
- Design parks and trails so they will be a source of civic pride and that they are easy to maintain
- Keep parks and trails well-maintained and clean, and promote stewardship of them



INCLUSIVE COMMUNITY FACILITIES & SERVICES

Provide services that reflect the diversity of Fort St. John's population

- Provide programs for all age groups and families to address the City's changing demographics
- Design programs to be inclusive of diverse ethnic and social groups, and those with a wide range of interests and skill levels
- Modify programs over time to address demographic changes, trends, and evolving interests
- Ensure that programs are affordable and accessible for all residents
- Design and manage parks and trails to improve safety and security



ECONOMIC VIABILITY & PARTNERSHIPS

Provide services and amenities in a financially responsible manner

- Pursue opportunities for private investment in recreation facilities through public/ private partnerships, and partnerships with Indigenous communities and other levels of government, for development and maintenance of infrastructure
- Collaborate with School District 60, Northern Lights College, and University of Northern British Columbia for shared use of facilities, and with other colleges, surrounding jurisdictions, and private industry to provide complementary services
- Develop cost-sharing and cost-recovery strategies for new and existing facilities
- Provide capacity-building workshops for community groups



YEAR-ROUND HEALTHY & ACTIVE LIVING

Encourage as many people as possible to participate in activities throughout the year

- Increase amenities and recreation opportunities that inspire more winter use
- Focus on the user's experience when designing parks and facilities
- Encourage and promote cycling and walking as recreation activities and as viable modes of transportation
- Improve marketing of events and programs

RECOMMENDATIONS

The next several pages outline the recommendations across various segments of the City's Parks and Recreation functions. The recommendations are divided into the following subheadings; however, not all subheadings apply to each section:

- Land Acquisition
- Planning and Design
- Capital Development
- Operations and Management

Each table includes the recommendation, the source of the recommendation and the timeframe for implementation. The City has accomplished many of the recommendations set out in the 2017 Parks and Recreation Master Plan. Other recommendations have been revised to align better with current needs and priorities, and new recommendations have been added.

Based on the responses received during the engagement opportunities, priority charts were developed with comparisons to the 2017 Parks and Recreation Plan. These priority charts provide a quick look into the top 10 priorities for both indoor and outdoor recreation.

CLOSING

The 2017 Parks and Recreation Plan was intended to cover a 15 to 20 year timeframe. The plan was revisited within six years as many of the recommendations from the plan were implemented and the City wanted to review the remaining recommendations with the community and identify new priorities.

Therefore, while this new plan is intended as a guide for 10 years, various factors could trigger a need to update the plan again before 2033, such as, population growth different from expectations or the use characteristics and trends are changing.

The critical factor is to remain committed to the vision, goals, and objectives in all aspects of parks and recreation planning and service delivery.
